Warren Mosler's Spoliation of Evidence

[legal term for unethically hiding evidence in a lawsuit]

Men in power seek and use CONTROL in order to conquer. It is extremely difficult to fight against those who control and do unethical things. THE TRAGIC TRUTH: For the most part, *Men Like Mosler* get away with it.

In the 11-year-long lawsuit between me and Mosler; Warren Mosler CONTROLLED both the Mosler Automotive ('MACC') email server and his personal gmail account. Thus, Mosler controlled the vast majority of the information. CONTROL.

In Florida, the party who controls the information about the lawsuit is legally-required to give the information to the opposing side. Increasingly, this is simply REFUSED, but the refusal is done unethically via lying that no evidence exists.

Warren Mosler used this tactic – stating on the record the answers "none" "none

Even when *Men Like Mosler* are caught doing unethical illegal things, there is NEAR-ZERO PUNISHMENT for them....therefore *Men Like Mosler* almost-always decide to do unethical things (instead of being honest), because ordinary people simply cannot afford to fight back through the legal system.

The "none" was discovered to be over 18,500 pages (a stack 7 feet tall) of hidden evidence that we discovered after Mosler's personal attorney, Alan Simon, panic'd over having his personal computer searched in deposition....hmm.

Alan Simon is also the fellow who got away with over \$220,000 in Insurance Fraud money on the illegally-built 2004 Mosler MT900s with known-fire-risk because Mosler hid the evidence for over 5 years; until the Statute of Limitations for fraud ran out.





Timeline of Warren Mosler's Hiding of a 7-foot-tall stack of Evidence for over 5 years

- 1) **2011**: The bizarro events occurred. *The central theme was GREED.* Instead of simply honoring his agreements, Warren Mosler attempted to TAKE everything from me.
 - a. Mosler is a multi-billioniare....so why the hell would he do such a thing? Why not simply honor his agreements????
 - i. ANSWER: *Men Like Mosler* take Pleasure in the Pain of others.
 - b. Ordinary people (myself included) don't encounter this level of greed in their lives, so we just don't see it coming. It is tough to imagine that level of evil walking around Publix.
 - c. Ordinary people don't believe that *Men Like Mosler* are stealing from them via Money Printing; but the economic facts are that the extra money winds up in the pockets of the uber-rich. It is slowly siphoned off from ordinary people who work for a living.
 - i. *Men Like Mosler* find it amusing that we struggle to buy groceries...and that we don't realize how/why it happened.
- 2) **2013:** After Mosler has toyed with me for over a year; stringing me along that I might be able to utilize my \$100,000 deposit to buy MACC and make my dreams come true > Mosler sold MACC to RP High Performance and indemnified them against the contracts SEI held with MACC.
 - a. Warren Mosler took on EXTRA RISK, simply to see my dreams be destroyed. That is sick.
 - b. Furthermore, Mosler took \$500,000 from RPI instead of the \$650,000 that I had offered. Thus, Mosler took on extra risk AND \$150,000 less money simply to ensure I could not be successful.
 - c. Warren Mosler instructed his attorney, Steven Weber (from Miami) to mock me about Mosler taking MACC out of my reach:

THIS MAN IS SHADOW-CONTROLLING YOUR MONEY. YOU SHOULD BE TERRIFIED.

- I have done some volunteering (trying to fix the system see JudgeX.org) in the pursuit of curtailing/eliminating Human Trafficking. Human Trafficking is the PC term for taking little girls from their parents and having them be raped until death (the typical lifespan for a sex-industry little girl is 7 years).
- One of the ways the little girls die is being killed for pleasure by the rapist.
- *Men Like Mosler* take pleasure in the pain of weak souls they dominate.
- It is amusing to Warren Mosler that I was "heartbroken". Taking pleasure in my pain.

- 3) **2014:** I and my company, SEI, sent approximately 100 different "Requests for Production" that identify specific documents that Warren Mosler is legally-required to send to me as part of the fair pursuit of justice.
 - a. Approximately 98% of the answers from Warren Mosler were "none" indicating no documents (emails) exist.
 - i. 7 years of designing building vehicles at MACC
 - ii. Employees / Distributors in 5 countries
 - iii. No emails
 - b. If the answer wasn't "none", it was something like "objection, relevance" or "attorney-client privileged".
 - c. Plaintiffs were given approximately 10 sheets of paper, many of which were halfemails. One of them was a half email "Any pressure you can put?" I wonder if that was done on purpose.
- 4) **2018**: Plaintiffs file a Motion for Sanctions for Spoliation, and a hearing occurs on August 24, 2018.
 - a. The burden of proof that emails existed in the first place is no the party who doesn't have the emails.
 - b. Since Mosler says they don't exist and I say they do exist; a 3rd party is needed to 'break the tie'. I serve the Vice President of Global Operations, as she isn't a party to the lawsuit.
 - i. I know she is in Mosler's pocket, but I don't believe she will risk going to prison for Perjury in order to lie for him.
 - ii. I'm wrong.
 - iii. I now know that witnesses commit perjury regularly in Civil Court and are [never] punished for it...therefore **PERJURY PAYS.**

c. MACC-VP testifies:

- i. Warren Mosler wasn't making the operational decisions for MACC [building cars illegally / defamation / etc].
 - 1. ALTERNATE REALITY TESTIFIED TO THE JUDGE: "Mostly, since he is he [Warren Mosler] has a lot of other entities that he was involved with most of what I did was through the direction of Alan Simon"
 - 2. ALTERNATE REALITY TESTIFIED TO THE JUDGE: Q: You said you had to deal with Alan Simon, Mr. Mosler's attorney, correct? VP-ANSWER: "Yes."
 - 3. ALTERNATE REALITY TESTIFIED TO THE JUDGE: Q: Okay, When anything odd, out of the ordinary came, how did you deal with Mr. Mosler? VP-ANSWER: "I usually would talk to Alan."
- ii. She didn't remember emails.
 - 1. ALTERANTE REALITY TESTIFIED TO THE JUDGE: "I'm very proactive on the **phone**. I do better on the **phone** than e-mail, even to this day, to me."
 - 2. ALTERANTE REALITY TESTIFIED TO THE JUDGE: "We did a lot on the **phone**, Alan and I, because I've always been a **phone** person."
 - 3. ALTERANTE REALITY TESTIFIED TO THE JUDGE: "Absolutely. Warren is very big on the **phone**."
- iii. MACC didn't build the 2012 Mosler RaptorGTR.
 - 1. ALTERNATE REALITY TESTIFIED TO THE JUDGE: "I heard RaptorGTR. So that's, perhaps, what it's going to be, but we didn't go into production"
 - 2. ALTERNATE REALITY TESTIFIED TO THE JUDGE: "I've never seen a picture of Number 2 [RaptorGTR]. I don't recognize the taillights."

RESULT: Because the MACC-VP did everything in her power to deny the existence of the 18,500 pages of emails that I now have; AND she presented convincing ALTERNATE REALITIES to Judge Hafele...the Judge denied our Spoliation Motion. The Court stated that it denied Plaintiffs Motion because Plaintiffs couldn't prove that the emails existed in the first place.

I was (of course) stunned at the VP's testimony. It took approximately 8 months of depositions in multiple states to get Alan Simon to crack about the existence of the emails.
